

Fan Zone Predict & Win Terms and Conditions

1. Organiser and Activation

- 1.1 This Football Predict & Win activation is organised by Century Financial Consultancy LLC ("Century", "we", "us" or "our") at the FanZone by McGettigan, located at Reem Mall, Abu Dhabi, UAE, during the campaign period notified by Century.
- 1.2 The activation is a free-to-enter customer engagement and brand activation campaign. It is not a betting activity, gambling activity, lottery, raffle, prize draw or game of chance.
- 1.3 "FIFA" and related names, marks, logos, event names and identifiers are protected intellectual property of Fédération Internationale de Football Association and/or its affiliates or rights holders. This activation is organised solely by Century and is not organised, hosted, sponsored, endorsed, administered, promoted by, or otherwise associated with FIFA, any FIFA affiliate, tournament organiser, football team, player, broadcaster, venue operator or rights holder.
- 1.4 Any reference to FIFA, the FanZone by McGettigan Abu Dhabi, football matches, teams, venue or related event context is made only for identification and descriptive purposes. Century does not claim any ownership rights in any third-party names, marks or intellectual property.

2. Participation Rules

- 2.1 Participation is open to individuals attending the activation who submit a valid entry through the official campaign landing page by scanning the campaign QR code, providing the required details, and submitting an exact score prediction for the available match or matches before kick-off.
- 2.2 Predictions must be for the exact final score at the end of regular time only, including stoppage time. Extra time, penalty shoot-outs or any result after regular time will not be considered.
- 2.3 Once submitted, a prediction cannot be edited, changed, withdrawn or resubmitted. Entries that are late, incomplete, duplicate, inaccurate, submitted after kick-off, affected by technical or submission errors, or submitted other than through the official campaign landing page may be treated as invalid.
- 2.4 Participants must provide true, accurate and complete information. Century may reject or disqualify any entry or participant where it reasonably considers that the activation has been misused or these Terms and Conditions have been breached.
- 2.5 Century's system records of entries, submission times and predictions shall be final.

3. Reward

- 3.1 A participant whose exact score prediction matches the final score at the end of regular time for the relevant match may be eligible to receive one free drink voucher, subject to verification, availability, venue rules, campaign limits and these Terms and Conditions.
- 3.2 If a participant correctly predicts more than one eligible match, Century may issue one voucher for each correct prediction, subject to any campaign limits determined by Century.
- 3.3 The voucher will be issued only by an authorised Century representative and may be redeemed once for one eligible drink at the participating venue.
- 3.4 The voucher is non-transferable, non-refundable and cannot be exchanged for cash, credit, any financial product, financial instrument or any other item.
- 3.5 Unless otherwise stated on the voucher, the voucher shall remain valid until the end of the relevant football event on July 19, 2026.
- 3.6 Lost, damaged, expired, copied, duplicated or already-redeemed vouchers may not be replaced.

4. Venue, Age and Redemption Requirements

- 4.1 Century is not the supplier of any drink or venue service. Redemption and service shall be handled by the participating venue in accordance with its own licence, rules and policies.
- 4.2 The voucher is subject to venue rules, availability, applicable laws, age restrictions, identification checks and responsible service requirements.
- 4.3 If the voucher is redeemable for an alcoholic beverage, the participant must be at least 21 years old and must provide valid identification if requested by the venue.
- 4.4 The venue may refuse redemption or service if the voucher is invalid, expired, already redeemed, or if the participant does not meet the venue's legal, operational or policy requirements. Century shall not be responsible for any such refusal.

5. Communication and Data

- 5.1 Participants may be contacted by Century using the contact details provided in the campaign form for activation administration, entry verification, reward fulfilment, campaign records and related communication.
- 5.2 Participants are responsible for providing accurate and complete contact details. Century shall not be responsible for failed or delayed communication due to incorrect, incomplete or outdated information.
- 5.3 By submitting the campaign form and accepting these Terms and Conditions, the participant acknowledges and agrees that Century may use the contact details provided to send activation-related communications and, subject to applicable laws, marketing and promotional communications from Century, including details of separate offers and promotions.
- 5.4 Participants may opt out of receiving marketing and promotional communications from Century at any time by using the unsubscribe option or other opt-out method provided in such communications. Opting out will not affect communications necessary for administering this activation.
- 5.5 Century will process personal data in accordance with applicable privacy and data protection requirements and Century's privacy policy.

6. Separate Complimentary CFD Share Offer

- 6.1 Century may separately contact participants with details of a complimentary CFD share promotional offer where permitted under applicable laws and these Terms and Conditions.
- 6.2 The complimentary CFD share promotional offer is separate from this activation and is not a reward for participating in this activation, making an incorrect prediction or submitting a campaign form.
- 6.3 The activation period for this Fan Zone Predict & Win activation and the validity period for any drink voucher are separate from the campaign period applicable to the complimentary CFD share promotional offer. The complimentary CFD share promotional offer shall be governed by its own separate terms and conditions, including its own eligibility criteria, claim period and expiry date, which currently runs until August 31, 2026, unless amended, withdrawn or extended in accordance with those separate terms.
- 6.4 Participation in this activation does not create any entitlement to receive any CFD share, financial product, account benefit or investment-related reward.
- 6.5 Any complimentary CFD share promotional offer shall be subject to separate terms and conditions, eligibility requirements, onboarding, KYC, account approval, product availability, risk disclosures, Century's standard terms of business and applicable regulatory requirements.

- 6.6 Nothing in this activation, the voucher reward, any complimentary CFD share promotional offer, the campaign landing page or any related communication constitutes investment advice, financial advice, portfolio management, a personal recommendation, an offer to sell, or a solicitation to buy or sell any financial product.
- 6.7 Trading and investing involve risk, including the possible loss of capital. The value of any stock or financial instrument may rise or fall, and past performance is not a reliable indicator of future performance.

7. General Conditions

- 7.1 Participation in the activation does not guarantee any reward, benefit, account opening approval, financial product or promotional offer.
- 7.2 Century may amend, suspend, extend, cancel or terminate the activation at any time without prior notice, including due to operational issues, venue requirements, technical failures, regulatory concerns, match schedule changes, force majeure events or any matter beyond Century's reasonable control.
- 7.3 Century shall not be responsible for technical failure, network issues, internet disruption, QR code issues, landing page issues, device errors, delayed submissions, incomplete submissions, incorrect data entry or any other matter that affects a participant's ability to participate.
- 7.4 Century may take reasonable steps to verify entries, preserve the integrity of the activation and determine eligibility for rewards. Century's decision regarding entries, eligibility and rewards shall be final, subject to applicable law.

8. Liability

- 8.1 To the maximum extent permitted by applicable law, Century, the participating venue, and campaign partners shall not be liable for any loss, damage, claim, cost, expense, injury, disappointment, inconvenience or other consequence arising from participation in the activation, non-receipt of a reward, refusal of voucher redemption, use of any reward, or any separate promotional communication.
- 8.2 Nothing in these Terms and Conditions shall exclude or limit liability where such liability cannot be excluded or limited under applicable law.

9. Governing Law and Disputes

- 9.1 These Terms and Conditions shall be governed by the laws of the United Arab Emirates as applicable in the Emirate of Dubai.
- 9.2 Subject to applicable law, the courts of Dubai shall have jurisdiction over any dispute arising out of or in connection with this activation or these Terms and Conditions
